REGULAR COUNCIL MEETING MINUTES

Attending members included: Mayor Mike Frisbie, Council Members, Jake Mattingley, Joe Whitaker, and Rochelle Schreckhise. Also present were City Administrator Teresa Whitaker, City Clerk April Umphenour, Roger Simms of the Linn County Journal, and Jackie Taylor of the *Linn County News*.

ABSENT: Aaron Portman and Melanie Staton

CALL MEETING TO ORDER: Mayor Frisbie opened the meeting at 6:07 pm with The Pledge of Allegiance.

A. MAYOR'S COMMENTS/EXECUTIVE SESSION:

Teresa requested a 10- minute executive session to include non-elected personnel to include Tristan Snyder, pertaining to employee conduct. Jake made a motion to approve a 10-minute executive session returning at 6:19, Rochelle second, motion carried 3-0.

Executive session ended at 6:19 with no action taken.

Burton Harding requested a 10-minute executive session for potential litigation. Jake made motion to approve the executive session returning at 6:31, Rochelle second, motion carried 3-0.

Executive session ended at 6:31 with no action taken.

B. CITY ADMINISTRATOR REPORT & FINANCIAL OVERVIEW:

Pay increase for the City of Pleasanton Volunteer Firefighters – Teresa suggested raising the pay for local volunteer firefighters after the initial 3-hour mark is surpassed. Currently, there is a \$35.00 pay amount in place for the first three hours they are on a call. After the initial three-hour window, they are then paid minimum wage. Jake made a motion to raise the pay from \$7.25 an hour, to \$15.00 per hour for every hour worked beginning at the fourth hour, Joe second, motion carried 3-0.

Jake made a motion to suspend Sandy Ward for two weeks without pay for conduct unbecoming a city employee, Joe second, motion carried 3-0.

Teresa suggested changing the council pay period from a 30-day period to pay out once a year on December first beginning 2022. It was also stated that should a council member leave during the year, they will receive all pay due at their time of leaving. Jake made a motion to approve, Rochelle second, motion carried 3-0.

Opioid settlement – Pleasanton would receive a total of \$12,896.25 if the current formula stated is correct. The payout formula and payout periods are not yet complete.

Budget is almost done but Teresa is going to send it to the state of Kansas for a final check prior to making it official. According to Teresa, Pleasanton is not planning to surpass the revenue neutral rate.
