- Solicit bids for roof repair on the gazebo at Dunlap Park
   Motion was made by Herring, seconded by Schreckhise, to solicit bids to re-shingle the roof on the gazebo at Dunlap Park. Motion carried unanimously. Kershner to prepare the bids specifications.
- Resolution to add City Treasurer to bank accounts
   Motion was made by Randall, seconded by Herring, to approve Resolution Number 447: A RESOLUTION
   AUTHORIZING A CERTAIN INDIVIDUAL TO SIGN CHECKS FOR THE ACCOUNTS HELD IN THE
   NAME OF THE CITY OF PLEASANTON AND TO REMOVE A CERTAIN INDIVIDUAL FROM THE
   SAME ACCOUNTS. Motion carried unanimously.
- Consider 1.00 per hour raise for Taylor Robinson requested by John Harrington Motion was made by Randall, seconded by Herring, to enter into a 10-minute executive session for non-elected personnel, to reconvene back to the council room at 7:06pm. Motion carried unanimously, and council entered executive session at 6:56pm. Council reconvened to the council room at 7:06pm with no action taken.

Motion was made by Randall, seconded by Schreckhise, to correct an oversight in the recently adopted pay plan by giving Taylor Robinson \$1.00 per hour raise for having her CDL. Motion carried unanimously.

- \$30 Rural Service Charge
  Following discussion, motion was made by Randall, seconded by Schreckhise, to have the city attorney prepare
  an ordinance repealing the \$30.00 service charge for customers having city water service that live outside of city
  limits. The \$5.00 service charge remains the same. Motion carried with Herring abstaining.
- City logo
  It was the consensus of the council to have a city logo and slogan contest for the City of Pleasanton. All suggestions are due at city hall by July 31, 4:30pm. Information to be made public regarding the contest.
- Closing Main Street from Broad to 9th on September 14, from Noon 6:00pm for Skylar Gabrini car show Motion was made by Herring, seconded by Schreckhise, to close Main Street as requested on September 14, from noon until 6:00pm for a car show. Motion carried unanimously.

# **UNFINISHED BUSINESS:**

#### COUNCIL MEMBER DISCUSSION:

- Randall has been approached by citizens wanting council to speak to the county commissioners regarding when
  the Senior Citizen Center in Pleasanton will be open. Herring informed council it had been discussed earlier in
  the day at the Linn County Commissioners Meeting and they hoped to have it open in July.
- Randall also requested council to think about what the city could add to the Memorial Day Celebration next year.
- Randall requested the trees that have been put into the East Lake for habitat be pushed deeper into the water or removed as she had complaints that people were unable to shore fish where the trees were now.
- Schreckhise questioned the new umbrellas for the pool.
- Herring had nothing at this time.
