Regular Council Meeting Minutes

CALL MEETING TO ORDER: Mayor Young called the meeting to order at 6:00pm. The Pledge of Allegiance was recited. Council members present: Portmann, Herring, Schreckhise, Skipper, and Randall. Other city officials present: City Attorney Jacklyn Paletta, Chief of Police Tristan Snyder, Code Enforcement Officer Candy Houtman, and City Administrator/Clerk Becky Hegwald.

The agenda was amended to remove the executive session for non-elected personnel and to have an additional executive session for attorney/client privilege. Motion was made by Randall, seconded by Portmann, to approve the amended agenda.

## PUBLIC SPEAKER IDENTIFICATION AND PUBLIC COMMENT:

- Jessica & Patrick Huntley building permit and stalking
  The Huntleys questioned why a building permit was required for a shed and voiced concerns about being stalked.
- Zach Ross using the community center for dog obedience classes
  Ross explained to council that he would like to use the community center for dog obedience classes once a week for six weeks. He asked the council to consider lowering the cost of out-of-town rental on the community center as he is bringing a service to town and would like to keep the cost of the class low to allow more people to participate.

   Motion was made by Randall, seconded by Schreckhise, to enter into a 10-minute executive session for attorney/client
   privilege, without Skipper present, to reconvene to the council room at 6:41pm. Motion carried with Skipper
   abstaining. Council entered into executive session at 6:31pm. Council reconvened to the council room at 6:41pm with
   no action taken.

Motion was made by Randall, seconded by Portmann, to reimburse Skipper for the pump installed at the swimming pool with half payment coming out of the 2024 budget and the remaining half payment coming out of the 2025 budget. No interest will be paid, and Randall stressed that purchasing procedures need to be followed in the future. Motion carried with Skipper abstaining.

- Set workshop to discuss slogan/logo contest results
   It was the consensus of the council to hold a workshop at 5:30pm prior to the next council meeting on September 16, to allow council to discuss the entries in the Pleasanton logo and slogan contest.
- Mayor Young read a thank you note from the Dent family.

   Motion was made by Randall, seconded by Portmann, to accept sealed bids on the city owned lot across from the community center. Motion carried with Herring voting no.
- Request from General Pleasonton Days Committee for donation
  Hegwald had received a request from the General Pleasonton Days Committee for a donation towards General
  Pleasonton Days. Motion was made by Portmann, seconded by Skipper, to give a donation of \$1000 to the event.
  Motion carried unanimously.
- Street closure request for General Pleasonton Days
  Discussion was tabled to get more information on what times to close what streets.

Motion was made by Skipper, seconded by Herring, to have the 2025 Stars & Stripes Celebration on Saturday, June 28. Motion carried with Schreckhise voting no.
