Regular Council Meeting Minutes

**CALL MEETING TO ORDER:** Mayor Young called the meeting to order at 6:00pm. The Pledge of Allegiance was recited. Council members present: Portmann, Schreckhise, Skipper, and Randall. Absent: Herring. Other city officials present: City Attorney Jacklyn Paletta, Chief of Police Tristan Snyder, and City Administrator/Clerk Becky Hegwald.

### APPROVE CONSENT AGENDA

Approve September 30, 2024, Council Meeting Minutes

Motion was made by Randall, seconded by Portmann, to approve the consent agenda as printed. Motion carried unanimously.

### NEW BUSINESS:

- Open bids for lot at 9<sup>th</sup> & Main  
Two bids were received and opened. As per policy, the bid information was not released at this time. Hegwald to contact both bidders and see if they would like to raise their bids without knowing what the other bid is. Bid information and a decision to be made at the next council meeting.
- Adopt Resolution Number 450  
Motion was made by Portmann, seconded by Randall, to adopt Resolution Number 450 as printed; A RESOLUTION ADOPTING THE KANSAS HOMELAND SECURITY REGION J HAZARD MITIGATION PLAN. Motion carried unanimously. The resolution allows the city to be eligible to apply for FEMA funding in the event of an emergency.
- Adopt Resolution Number 451  
Motion was made by Randall, seconded by Portmann, to adopt Resolution Number 451 as printed; A RESOLUTION CREATING A CROSS-CONNECTION POLICY. Motion carried unanimously.
- BNSF Railroad Crossings Closure Request  
Hegwald had been contacted by a representative from BNSF Railway regarding the possibility of a crossing closure in Pleasanton. Council requested the representative to attend the next council meeting for discussion on the matter.
- Set Family Movie Day  
It was the consensus of council to not have a Family Movie Day this month.
- Mini excavator  
Hegwald presented council information regarding the purchasing of a mini excavator. The city owns a backhoe that is rarely used and a small roller that is not used and would like to trade them in for a mini excavator. Hegwald to obtain more information and discussion will be held at the next meeting.

**COUNCIL MEMBER DISCUSSION:** No council member had any items to be discussed.

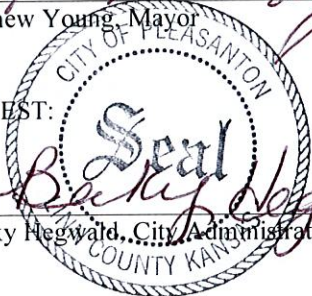
