REGULAR COUNCIL MEETING MINUTES

Attending members included: Council Members Aaron Portman, Joe Whitaker, Melanie Staton, and Rochelle Schreckhise. Also present were City Administrator Teresa Whitaker, City Clerk April Umphenour, City Attorney Burton Harding, and Jackie Taylor of the *Linn County News*

CALL MEETING TO ORDER: Mayor Frisbie opened the meeting at 6:00 pm

- A. MAYOR'S COMMENTS/EXECUTIVE SESSION: Mayor Frisbie welcomed the new and returning Council Members; Rochelle Schreckhise, Aaron Portman, and Joseph Whitaker. The mayor then thanked them for their willingness to serve their community, and asked the city clerk to swear them in. Mayor then opened the condemnation hearing scheduled.
- B. CITY ADMINISTRATOR REPORT & FINANCIAL OVERVIEW: Gave a financial overview of the 2021 financial standing.

Teresa then addressed a request to borrow tables and chairs from the community center from a patron of the community. Because chairs and tables have been lost and/or not returned upon lending them in the past, she suggested to the council that there be a deposit and/or rental fee applied to all chairs and tables upon leaving the facility. She suggested applying a rental fee and deposit for a maximum of 3 days use for table and chairs from the community center. Aaron made a motion to approve charging a deposit in the amount of \$100.00 for a maximum of 2 tables and 12 chairs for a period not to exceed 3 days. Melanie second, motion carried 4-0.

Because of the difficulty to obtain cold patch currently, it is \$100/ton as opposed to \$50/ton which was the cost in the past when the city purchased it. The Christmas lights along Main Street have been taken down. There was a water line break that has been repaired. Mayor then asked if there is currently any type of surge-protection on the lift stations. Joey said he is still looking at generators for backup power.
