Street closure request from the Pleasanton Nazarene Church
 A request was presented from the Pleasanton Nazarene Church to close Laurel Street between 10th and 12th
 Streets on Saturday, July 20th, from 9:00am – 4:00pm to allow for a community block party.

Motion was made by Portmann, seconded by Randall, to approve the street closure as presented. Motion carried unanimously.

• Street closure request from the Chamber

A request was presented from the Pleasanton Area Chamber of Commerce to close 9th Street between Main Street Main Street and Linn Street on Sunday, July 7th, from 4:00pm – 9:00pm to allow for a Walk Main Street Event.

Motion was made by Portmann, seconded by Schreckhise, to approve the street closure as presented. Motion carried unanimously.

UNFINISHED BUSINESS:

Rural service fee

Motion was made by Randall, seconded by Skipper, to approve Ordinance Number 2056 as corrected; AN ORDINANCE RESCINDING SECTION 15-221(e) OF THE CODE OF THE CITY OF PLEASANTON, KANSAS PERTAINING TO WATER BILL SERVICE FEES.

Following a lengthy discussion the motion failed with Portmann, Schreckhise, and Skipper voting no and Herring abstaining.

Motion was made by Portmann to raise the rural water service fee to \$50,00. The motion died for lack of a second.

Depot Street Ordinance

Motion was made by Portmann, seconded by Randall, to approve Ordinance Number 2055; AN ORDINANCE CREATING LOADING AND UNLOADING ZONE FOR BUSINESSES WITHIN THE CITY OF PLEASANTON, KANSAS, AND PROVIDING FOR THE ENFORCEMENT OF. The loading and unloading zone will be:

- ❖ Depct Street, between 6th Street and 11th Street
- 7th Street between Depot Street and Main Street
- ❖ 8th Street between Depot Street and Main Street.

Motion carried unanimously.

CITY ATTORNEY: Paletta informed council that if they would like the ordinance that failed amended to let her know so that she can have it ready to be voted on at the next meeting.

COUNCIL MEMBER DISCUSSION:

- Randall questioned Snyder regarding police cars on Tiger Road. Snyder informed council that the police department regularly checked the airport. Randall also requested the city attorney's name be updated on the city website.
- Skipper gave a run down on the Stars & Stripes Celebration this coming weekend.
- Schreckhise said she hoped the community would get more involved in the Stars & Stripes Celebration next year. She also requested a free swim day on July 4th.
- Herring requested to be allowed to have an employee appreciation lunch on Friday, July 26th. It was the consensus of the council to allow the employee appreciation lunch.
- Portmann made it clear that he would back city employees on issues and requested council to leave the day-today operations to the city administrator.
