CALL MEETING TO ORDER: Mayor Young called the meeting to order at 6:00pm. The Pledge of Allegiance was recited. Council members present: Portmann, Herring, Schreckhise, Skipper, and Randall. Other city officials present: Police Chief Tristan Snyder and City Administrator/Clerk Becky Hegwald.

MAYOR'S COMMENTS/EXECUTIVE SESSION: None

CITY ADMINISTRATOR & DEPARTMENTAL REPORTS & FINANCIAL OVERVIEW:

- It was the consensus of the council to split any money raised for the Stars & Stripes Celebration on June 29th to be split 50/50 between swimming pool improvements and next year's July 4th celebration.
- Hegwald informed council that the STARS Program is willing to help with rebuilding the kennels at the pound that were cited during the last state inspection. Motion was made by Portmann, seconded by Herring, to allow Hegwald to authorize the repair not to exceed \$5,000. Motion carried unanimously.

 raise for his exceptional work. After a lengthy discussion regarding the lack of a consistent pay plan, the motion
 failed with Randall and Schreckhise voting yes, Skipper and Portmann voting no, and Herring abstaining. Mayor
 Young broke the tie with a no vote.
- It was the consensus of the council to have employees that use personal vehicles turn in mileage for reimbursement.

CITY ATTORNEY: Burton Harding was absent.

NEW BUSINESS:
