AN ORDINANCE ANNEXING TO THE CITY OF PLEASANTON, KANSAS CERTAIN PROPERTY OWNED BY THE CITY.

WHEREAS, the Governing Body of Pleasanton, Kansas is authorized by K.S.A. §12-519 et. seq to annex by ordinance certain land owned by the City; and

WHEREAS, the City of Pleasanton owns the below described property,

## NOW THEREFORE, IT IS HEREBY ORDAINED BY THE GOVERNING BODY OF PLEASANTON, KANSAS:

1. The below described tract of land are hereby annexed into the City of Pleasanton, Kansas:

A tract of land in the Southeast Quarter of Section 30, Township 21 South, Range 25 East of the 6<sup>th</sup> PM, being a part of a tract of land described as tract (a) in a deed recorded in Book 364, Page 268 in the Register of Deeds Office, Linn County, Kansas and described as follows: COMMENCING at the Northwest corner of said Quarter Section; thence on an assumed bearing of North 87 degrees 28 minutes 52 seconds East, 66.31 feet along the North line of said Quarter Section to the POINT OF BEGINNING; FIRST COURSE, thence South 01 degree 46 minutes 39 seconds East 525.04 feet to the South line of said tract of land; SECOND COURSE, thence North 87 degrees 28 minutes 52 seconds East, 218.38 feet along said South line; THIRD COURSE, thence North 24 degrees 28 minutes 09 seconds West, 566.03 feet to the POINT OF BEGINNING. Containing 1.32 acres, more or less.

- 2. Upon inclusion in the City, the Property hereby annexed shall be zoned "CP-2".
- 3. This ordinance shall be effective upon its passage and publication of a summary hereof in the official newspaper of the City of Pleasanton, Kansas, and publication of the entire ordinance on the City's official web site for at least one week.
- 4, Upon passage and publication, a certified copy of this ordinance shall be filed by the City Clerk with County Clerk and with the County Register of Deeds, pursuant to K.S.A. \$12-522.
