 Discussion was held on the updated public works job descriptions. Motion was made by Portmann, seconded by Schreckhise, to approve the job descriptions with noted changes. Motion carried unanimously.

 Motion was made by Herring, seconded by Portmann, to approve Resolution Number 445; A RESOLUTION AUTHORIZING CERTAIN INDIVIDUALS TO APPLY FOR A CITY CREDIT CARD WITH A LIMIT OF \$1,500.00 FOR THE CITY OF PLEASANTON. Motion carried unanimously.

 Motion was made by Portmann to give Madison Stanley and Mike Kershner \$1.00 an hour raise for their
 Class 2 Water Certifications. Motion died for lack of a second. Following further discussion, motion was
 made by Portmann, seconded by Herring, to give Madison Stanley and Mike Kershner \$1.00 an hour raise
 for their Class 2 Water Certifications. Motion carried with Randall abstaining.
- Discussion was held on moving Jim Herring to the public works employee position in charge of mowing.
 Motion was made by Randall, seconded by Portmann, to move Jim Herring to the public works employee position in charge of mowing. Motion carried with Herring abstaining.
- Motion was made by Randall, seconded by Schreckhise, to enter into a five-minute executive session, in the
 council chambers, for non-elected personnel to discuss job performance, to reconvene back to the council
 room at 7:44pm. Motion carried unanimously. Council entered into executive session at 7:39pm and
 reconvened to the council room at 7:44pm with no action taken.
