REGULAR COUNCIL MEETING MINUTES

Attending members included: Mayor Mike Frisbie, Council Members, Jake Mattingley, Joe Whitaker, Aaron Portman, Melanie Staton, and Rochelle Schreckhise. Also present were City Administrator Teresa Whitaker, City Clerk April Umphenour, Roger Simms of the Linn County Journal, and Jackie Taylor of the *Linn County News*.

ABSENT:

CALL MEETING TO ORDER: Mayor Frisbie opened the meeting at 6:00 pm with The Pledge of Allegiance.

A. MAYOR'S COMMENTS/EXECUTIVE SESSION:

Mayor said mid-term elections day will be August 02, 2022 and encouraged everyone to vote. Mayor then skipped to public speakers.

B. CITY ADMINISTRATOR REPORT & FINANCIAL OVERVIEW:

Teresa spoke about the new FEMA maps and information.

The police have picked up their new police car that was purchased through the GSA auction.

Reminded the council of the Brett Johnson Memorial Ride taking place 08/16/2022.

She then addressed the budget and proposed two different possibilities for the budget:

Meet the RNR which means the city of Pleasanton would drop the mil levy to 85.839% - **Aaron made motion to approve**, **Jake second**, **motion carried 5-0**.

Exceed the RNR of 85.839 and stay at the current mil levy of 93.380% -

Teresa then asked the council to entertain a motion to hire a fourth fulltime police officer – **Aaron made a motion to approve hiring a fourth officer**, **Jake second**, **motion carried 5-0**.

C. APPROVE CONSENT AGENDA: Aaron made a motion to approve as stated, Jake second, motion carried 5-0.

D. PUBLIC SPEAKER IDENTIFICATION: Mayor Frisbie-

Jesse Willard - not present.

Hayley Foltz - lodged complaints against Lifeguards and Teresa Whitaker.

Piper Smith - lodged complaints against lifeguards with accusations of bullying.

Council asked both Hayley and Piper to return to City Hall during normal business hours to file the required paperwork to lodge a formal complaint against any city employee included in the verbal complaint.

E. COUNCIL MEMBER DISCUSSION:

Jake –. Proposed hiring a fifth fulltime employee for Public Works. Will readdress this topic at the next meeting.

Aaron – praised the Public Works department for the excellent and diligent work they have performed keeping the water clean and clear.

Melanie – nothing currently.

Rochelle – passed along a compliment of a job well done to the Public Works department.

Joe – asked Joey if he was planning a burnout of the water lines this fall. Joey has been advised by a water specialist to avoid a burnout until spring and complete the burnout before the water heats up for the summer season.

F. CITY ATTORNEY: Burton Harding – spoke to the attorney for the state annexation for a portion of 69 Highway. He said that the City of Pleasanton was given the green light to move forward with annexation.

Council wants to see the boundaries set at the emergency turnaround extending a quarter mile past each, north and south of 1100 Rd exit on 69 Highway for a total of 1.50 miles of highway to be patrolled by the Pleasanton Police Dept.

G. CHIEF OF POLICE- Tristan Snyder – spoke about the workload on himself and his employees due to the shortage of personnel and requested permission to hire a fourth, fulltime police officer. Jake made a motion to approve hiring a fulltime Officer as of 01/01/2023, Aaron second, motion carried 5-0.

Chief Snyder then gave a current account of police activity YTD.

- I. PLANNING & ZONING: Teresa Whitaker nothing currently
- J. PUBLIC WORKS: Joey Morrisey will be working on 17th street and Sycamore for cold patch and will then branch out east on both roads. CDL will be coming out to look at the siren that is currently not working in North Park. Joey said there is an employee that would like to purchase the broken-down mower owned by the city. Aaron made a motion to approve the sale the broken-down mower for \$300.00, Jake second, motion carried 5-0.

 - 5. **Discuss/Consider -** approving a \$1.00 per hour raise for Taylor Robinson to take effect at the end of her six-month probationary period which will be on 08/21/2022. **Jake made a motion to approve, Aaron second, motion carried 5-0.**
