Regular Council Meeting Minutes

**CALL MEETING TO ORDER:** Mayor Young called the meeting to order at 6:00pm. The Pledge of Allegiance was recited. Council members present: Herring, Schreckhise, Skipper, and Randall. Portmann arrived at 6:05pm. Other city officials present: City Attorney Jacklyn Paletta (by Zoom), Chief of Police Tristan Snyder, Police Officer Kartman Highley, and City Administrator/Clerk Becky Hegwald.

## **APPROVE CONSENT AGENDA**

Approve February 20, 2025, Council Meeting Minutes

Regular Disbursements - \$12,664.40

Payroll Disbursements - \$25,808.09

Motion was made by Randall, seconded by Herring, to approve the consent agenda as printed. Motion carried unanimously.

## **UNFINISHED BUSINESS**

- Jason Hoskinson with BG Consultants – Street repair plan  
Jason Hoskinson with BG Consultants was present to discuss plans to start street repairs. He informed council of the KDOT Cost Share Program. Motion was made by Portmann, seconded by Randall, to apply for the cost share program with the city share not to exceed \$200,000.00. Motion carried unanimously.
- Compactor Agreement with Linn County  
Paletta had reviewed the compactor agreement with Linn County and her recommendation was to sign the agreement. Motion was made by Randall, seconded by Portmann, to sign the Compactor Agreement between the City of Pleasanton and Linn County. Motion carried unanimously.
- Adopt Resolution #455 on Student Council Representative to the City Council (attached)  
Motion was made by Randall, seconded by Skipper, to adopt Resolution Number 455; A RESOLUTION OF THE CITY OF PLEASANTON, KANSAS, ESTABLISHING A STUDENT REPRESENTATIVE POSITION TO THE CITY COUNCIL. Motion carried unanimously.
- Adopt Resolution #456 on right-of-way easements (attached)  
After discussion, motion was made by Randall, seconded by Herring, to adopt Resolution Number 456; A RESOLUTION DECLARING THAT CITY-OWNED, ROADS, STREETS, OR RIGHTS OF WAY WHERE SURROUNDED BY PROPERTY OWNED BY ONE PRIVATE OWNER MAY BE IMPROVED BY PRIVATE OWNER AT HIS OR HER EXPENSE FOR THE BENEFIT OF THE CITY AND OWNER UPON REQUEST MADE TO THE CITY AND APPROVAL GIVEN IN WRITING, provided that the included application was changed to include a statement that certain city requirements may have to be met on a case-by-case basis. Motion carried with Portmann voting no.

## **NEW BUSINESS:**

- Bids on salt storage shed concrete  
After council reviewed the two bids received on the concrete work for salt storage, a decision was tabled until clarification on one of the bids could be obtained.


- Court appointed attorney for municipal court  
Paletta explained that more charges were being filed in municipal court instead of district court and if the charges were a jailable offense and the defendant could not afford an attorney they had a right to a court ordered attorney. Motion was made by Randall, seconded by Portmann, to provide a defendant with a court ordered attorney when necessary for \$400.00 per case. Motion carried unanimously. The attorney fee will be paid up front by the city, then if the defendant is found guilty, they will have to reimburse the city for the attorney fees.
- Community Center volunteers rental fees  
Discussion was held on waiving rental fees for volunteers who worked on the community center during construction. Motion was made by Herring, seconded by Skipper, to discontinue waiving the rental fees for volunteers who worked on the community center during construction as of January 1, 2026. Motion carried unanimously.
- Car cameras for police department  
Randall and Snyder explained the need for cameras in the police cars in addition to the cameras the police officers wear. Since the car cameras were not budgeted for, Snyder thought he could cut the cost of the part-time officers to allow the purchase of the cameras. Motion was made by Randall, seconded by Portmann, to purchase three car cameras from Axon Enterprise for the cost not to exceed \$8,000 per year for five years. At the end of the five years, the equipment will be replaced, and the contract is renewable at that time. Motion carried with Herring voting no.
- Recommendation from Planning & Zoning Board on platting request from Twin Buck Holding, LLC for 00000 E 1100 Road (behind Casey's)  
It was the recommendation of the Planning & Zoning Board to approve the platting request from Twin Buck Holding, LLC for 00000 E 1100 Road. Upon the Planning & Zoning Boards recommendation, motion was made by Randall, seconded by Herring, to approve the platting request from Twin Buck Holding. Motion carried unanimously.
- Set dates for city-wide yard sale and cleanup day  
It was the consensus of the council to set the date of the city-wide yard sales to coincide with the Junk on the Prairie Event, with cleanup day to be the following Monday.


