# APPROVE CONSENT AGENDA

Motion was made by Portmann, seconded by Schreckhise, to approve the consent agenda as printed. Motion carried unanimously.

CITY ADMINISTRATOR & DEPARTMENTAL REPORTS & FINANCIAL OVERVIEW: Becky Hegwald Hegwald asked for permission to waive the special use permit fees for 2025. Since the new code book will go into effect on April 9, she asked that residents be required to come in and get newly required permits, but not to charge them for it in 2025. It was the consensus of the council to charge \$1.00 for the 2025 permit.

include the City of Pleasanton in with the Linn County Rural Fire District.

  Motion was made by Randall, seconded by Herring, to adopt Ordinance Number 2059: AN ORDINANCE
  ADOPTING THE CODIFICATION OF ORDINANCES OF THE CITY OF PLEASANTON, KANSAS,
  PROVIDING FOR THE REPEAL OF CERTAIN OTHER ORDINANCES NOT INCLUDED THEREIN,
  EXCEPTING CERTAIN ORDINANCES FROM REPEAL AND SAVING CERTAIN ACCRUED RIGHTS AND
  LIABILITIES. Motion carried unanimously. After publication in the official paper, The Linn County News,
  Ordinance Number 2059 will go into effect on April 9, 2025.

   Schreckhise opened the one bid received for the hay ground lease. Motion was made by Portmann, seconded by Randall, to accept the bid from Dennis Clayborn in the amount of \$4,105.00 to hay the city ground at the East Lake. Motion carried unanimously.
- Request from Skylar Gabrini to close Main Street from Broad to 9th Street, June 14th from 9:00am to noon for cars and coffee event
   Motion was made by Portmann, seconded by Skipper, to close Main Street as requested on June 14th. Motion carried unanimously.
- Donation request from East Central Kansas Area Agency (attached)
   After discussion, it was the consensus of the council to hold off making a donation at this time.

**CITY ATTORNEY:** Regarding removing the stop sign at 6<sup>th</sup> & Tucker, Paletta informed council she would not advice removing the stop sign without having an engineer involved to do a traffic study.

**COUNCIL MEMBER DISCUSSION:** Portmann and Herring had both received complaints on speeding around Park Street and Palm. The police department to do a traffic study on speed going down Park Street and report back at next meeting.
